

## ALL GLASS ENTRANCES LETTER OF CERTIFICATION AND LIMITED WARRANTY

This will certify that the Tempar-Glas<sup> $\Box$ </sup> (tempered glass) and/or Laminated Glass furnished on the invoice(s) noted below, will meet or exceed the applicable performance criteria of the applicable specification(s) following:

- Safety Glazing Certification Council (SGCC<sup>®</sup>) in accordance with:

VGP warrants its doors and/or sidelight Rails/Patch Hardware (Door Products) to be free from defects in material and workmanship for a period of one (1) year from the invoice date, under normal use and installation, excluding normal wear and tear.

VGP warrants factory supplied closers (Closers) against defects in material and workmanship for a period of five (5) years from the invoice date, with an exception for Assa Abloy's closers which have a two (2) year warranty. (Consult specific closer manufacturer's warranty for additional information.)

Other hardware (Hardware) supplied by VGP, but manufactured and/or marketed by a third party will be covered by the stipulations set forth in the third party's warranty, if applicable, for a period limited by the third party's warranty or one (1) year, whichever comes first, commencing on the VGP invoice date.

For purposes of this warranty Door Products, Closers, and Hardware are referred to collectively as Product.

Portions of this warranty shall be void under, and/or not apply if any of the following circumstances should occur:

- Product that is not handled, used, maintained, glazed, or installed in compliance and accordance with VGP recommendations and instructions, or current industry standards including the Glass Association of North America (GANA) Glazing Manual, and GANA Fully Tempered Heavy Glass Door and Entrance Systems Design Guideline;
- Product that have been altered or modified in any way;
- Product for which the original purchaser did not pay in full;
- Product that is not designed for, or does not meet applicable building codes and regulations;
- · Product on or around which incompatible cleaners, solvents, acids, alkalis, paints or other chemicals have been used;
- · Glass is cracked, chipped, or broken, whether spontaneous, accidental, or from any other cause;
- Product that exceeds the recommended size, use, or weight limitations set forth in VGP Technical Bulletins, and the GANA guidelines applicable to the Product;


Certain metal finishes will discolor, corrode, stain, and/or tarnish from various causes including, but not limited to oxidation, chemical exposure, acid rain, and atmospheric conditions. Such characteristic reaction(s), whether occurring over time or when first received by buyer, irrespective of protective coverings or coatings, are considered natural and not covered by this warranty. Periodic cleaning of such metals will be necessary.
